Recent years, however, have brought a sea change in U.S.India relations, which was reflected in India s swift offer of full support for the U.S.-led war on terrorism following the September 11, 2001, terrorist attack on New York and Washington. The continuing U.S. concern in South Asia, however, is the reduction of tensions between India and Pakistan, which center on their competing claims to the former princely state of Kashmir, and the prevention of nuclear and ballistic missile proliferation. India and Pakistan have so far ignored U.S. and international pressure to sign the Nuclear Nonproliferation Treaty or the Comprehensive Test Ban Treaty (CTBT). On May 11 and 13, 1998, India conducted a total of five unannounced nuclear tests, setting off worldwide condemnation. Following India s lead, on May 28 and 30, Pakistan reported conducting six nuclear tests. As a result...
